4. Quick reference manuals will be provided for terminal on casual rental.
5. It will be the hirer's responsibility to ensure the unit is kept secure and free from damage.
6. Ansutek accepts no responsibility for lack of cellular coverage or EFTPOS network congestion. No refund will be given in these instances.
7. The merchant (hirer) must keep all receipts.
8. Ansutek will not be liable for any lost sales or EFTPOS transactions.
9. **\$100.00 + GST cancellation fee** applies for orders canceled once booked.
10. Prepayment is required for casual rentals
11. Ansutek requires a credit card number and expiry date to be used as security against the goods supplied and / or payment of the rental fee
12. Interest on overdue amounts accrues at 2% per month. The hirer will meet collection costs
13. Hire periods allow 1 day each way for courier time. **The hirer will be charged \$35 +GST for each day or part there of that the terminal is late.** Return courier costs are to be met by the merchant.
14. The hirer is required to deliver or return the terminal(s) to Unit A1, 710 Great South Rd, Manukau City, Auckland 2241, on the last day of the above agreed period.
